Executive Summary:

This poll of 1,476 Hillsborough County, Florida registered voters was conducted on August 2nd, 2017. This poll used the registered voter lists supplied by the state of Florida as of June 14th, 2017. The sample of voters that were contacted included random samples of registered voters within the boundaries of Hillsborough County, Florida.

The issues surveyed included questions related to the 2018 Hillsborough County, Florida general election.

Methodology:

The poll was conducted by an automated phone call polling system. The results were then weighted to account for proportional differences between the respondents' demographics and the demographics of the registered voter population of Hillsborough County, Florida. The demographics used were: political party, race, age and gender.

The sample of voters polled was chosen at random within the registered voter population within Hillsborough County, Florida.

The scientific results shown for the first question below has a sample size of 1,476 and a 2.6% Margin of Error at a 95% confidence level.

Summary of Scientific Results:
